

## Primrose Hospice Grand Raffle – Terms & Conditions

The Primrose Hospice Grand Raffle is licensed by the Gambling Commission under the Gambling Act 2005 ([www.gamblingcommission.gov.uk](http://www.gamblingcommission.gov.uk)).

All profits from the Primrose Hospice grand raffle are used to fund the work of Primrose Hospice.

### **Terms and conditions of Lottery participation:**

1. By purchasing an entry you agree to these terms and conditions. Any entry not complying with these terms and conditions will be invalid. Primrose Hospice decisions pursuant to these terms and conditions shall be final and binding.
2. You represent and agree that:
  - a. You are 16 years of age or over.
  - b. You are a resident of the United Kingdom.
  - c. You will not buy or purport to buy an entry in this raffle on behalf of anybody under the age of 16.
  - d. You will provide accurate entry information, including your name and personal address
3. You agree that you shall not be entitled to receive any prize if you are unable to substantiate to the Promoter your representations under paragraph 2.
4. Entry is open to all residents of the UK (including Primrose Hospice volunteers and staff members) but excludes: Chair of Trustees, Rod Laight.
5. Entry costs £1 per ticket, payable in advance, by cheque made payable to 'Primrose Hospice' cash, credit/debit card or BACS payment. Raffle tickets will be entered into the draw when the whole payment is received. Entries may not be sold to or by anyone under 16 years of age. Each ticket represents one entry only.
6. Primrose Hospice is not liable for any lost, stolen, delayed, incomplete or illegible entries, or entries that reach us after the closing date, or for any delay in bank payments. Proof of posting is not proof of delivery.
7. Primrose Hospice may (without giving any reason or notice, at its absolute discretion) decline to accept an entry.

8. Entries received via the Just Giving Grand Raffle page (<https://www.justgiving.com/fundraising/primrosehospicegrandraffle>) **must** include contact details. Any entry received not confirming contact will not be eligible for entry as we will be unable to contact the winner.

9. The draw is conducted on **Friday 16<sup>th</sup> November 2018**. The closing date for entries will be **Friday 2<sup>nd</sup> November 2018**. The draw takes place at Primrose Hospice, St Godwalds Road, Bromsgrove B60 3BW. All tickets will be put into a container and picked out by independents. The results of the draw are final and will be posted on our website within 3 weeks of the draw date.

10. Winners will be notified by telephone or in writing as soon as possible after the draw.
